## Terms and Conditions

- League participation is valid 4/1/2025 through 10/7/2025.
- League participation is not transferable.
- League participation is limited to 60 seniors.
- All senior league participants from the 2024 season will have the first chance to sign up as a renewing league participant for the 2025 league season. Prior year participants will have until March 25th, 2025 to renew.
- Based on availability, any remaining league spots will be sold on a first-come, first-served basis to Leawood Residents only. Leawood residents who were not league participants in the 2024 season may submit applications beginning March 26th, 2025.
- Based on availability, any remaining league spots will be sold on a first-come, first-served basis. Applications for new league participants and/or those who were not league participants for the 2024 season can be submitted applications on April 2<sup>nd</sup>, 2025.
- All league players are required to register in the Golf Shop prior to teeing off.
- As a daily-fee course, there will be dates in which tournament groups will take up the course. Due to this, there will be some dates where tee times will not be available to you as a league player.
- No fivesomes will be allowed on the golf course at any time.
- League players are eligible to receive 15 complimentary warm up balls the day of league play. Additional practice balls must be purchased at normal rates.
- League fees are non-refundable – in the event of a medical emergency or relocation out of the area, exceptions may be made by the GM and City of Leawood on a case-by-case basis.
- Acts of God or other developments out of the control of Troon Management or the City of Leawood will not constitute a pro-rated or full refund.
- In accordance with State and Local Laws, outside alcohol may not be brought on nor consumed on the premise. Any such items that are found will be confiscated and may result in the immediate termination of your league participation.
- You represent that you are familiar with the operation and use of a golf cart and agree to return the golf cart immediately following the completion of play in the same condition as when received. You agree to pay for any damage to the golf cart which may occur while the golf cart is in your possession. Further, you agree to waive, on behalf of yourself and your heirs, any and all rights to assert a claim(s), suits, damages, or cause(s) of action against Ironhorse Golf Club, the City of Leawood, KS, and Troon Golf, LLC which you have arising from use of a cart on the premises. **By signing this application you are accepting of our waiver language for yourself, and any others for whom you have paid.**
- Ironhorse Golf Club represents and warrants that it follows all applicable Federal, State, and Local Laws, Ordinances, and Executive Orders. As such, all patrons are also expected to comply and follow such regulations. Any instance of willful and/or repeated disregard for such regulations, and/or other socially unacceptable behavior, may result in the immediate termination of your Ironhorse Golf Association participation and being permanently barred from the facility.
- Ironhorse Golf Club reserves the right to terminate your league participation for violation of the terms and conditions.
- Ironhorse Golf Club reserves the right to modify this program at any time without advanced notice.
- Ironhorse Golf Club reserves the right to discontinue the program at any time without advanced notice, but would honor the timeframe remaining on any outstanding league participation.
